City Attorney Jones informed the Council that city staff recently conducted a Request for Proposals for Soil Remediation at the former Sylvan Middle School site. Woodside Homes is currently in the process of purchasing the site. During the due diligence period, Woodside Homes discovered a minor environmental issue. Materials found on site are slightly over the threshold of allowable debris for a residential development. This contract will perform remediation of the site in order to continue the escrow process with Woodside Homes.

PUBLIC HEARING

- SUBJECT: Urgency Ordinance Urban Lot Splits and Two-Unit Residential Development Related to SB 9
 STAFF REPORT: C. Kempenaar/ A. Bermudez RECOMMENDATION: The following is recommended;
 - Adopt urgency Ordinance No. 2021-007, An Urgency Ordinance of the City of Citrus Heights, California, adopting changes to Title 82 (Subdivisions and Land Development) and Title 106 (Zoning) relating to the implementation of Senate Bill 9 for the creation of urban lots splits and two (2) residential units per lot;
 - Adopt Resolution No. 2021-110, of the City Council of the City of Citrus Heights, California, authorizing the addition of a new application type referred to as Urban Lot Splits, to the Master Fee Schedule

Associate Planner Bermudez presented Council with an overview of the Urgency Ordinance regarding Senate Bill 9. Governor Newsom signed SB 9 in September 2021. The legislation requires a proposed housing development containing no more than two residential units within a single-family zoning district to be considered ministerially; without discretionary review or hearing, if the development meets certain requirements. The two parts of SB 9 include land division of a single lot into two lots and development of two housing units on a single property. SB 9 allows jurisdictions to implement objective standards, however these objective standards cannot preclude construction of two units of at least 800 feet. Urban Lot Splits will be allowed beginning January 1, 2022 according to SB 9. The Urgency Ordinance would allow Citrus Heights to implement its own set of standards for Urban Lot Splits within the city. Bermudez stated that while there are still many unanswered questions regarding SB 9, the ordinance could be revised as different challenges arise.

Council comments and discussion followed.

Mayor Middleton opened the public hearing at 8:29 p.m.

PUBLIC COMMENT:

Oleg Shishko addressed the Council regarding item 16. He inquired if the City did its due diligence prior to entering into escrow with Woodside Homes.

City Attorney Jones informed Mr. Shishko that the City did its appropriate due diligence in inspecting the Sylvan property.

Melissa Hayden addressed the Council regarding the handicap accessibility in and around the residential developments.

Cathy Morris addressed the Council regarding the Urgency Ordinance for SB 9 stating that while she didn't agree with the bill, the ordinance would allow Citrus Heights to have a limited say in standards.

Mayor Middleton closed the public hearing at 8:34 p.m.

20. <u>SUBJECT</u>: American Rescue Plan Act Funding Update <u>DEPARTMENT</u>: Administrative Services Department

Economic Development and Communications Manager Huber presented the proposed next phases for the COVID-19 Recovery Program. This presentation focuses on the second phase, Small Business & Non-Profit Recovery Grants, and travel, tourism, and entertainment recovery. Huber stated the City launched a Business Community Engagement survey on December 1, which received 52 responses.

Diane Ebbitt with the Citrus Heights Chamber provided an overview of their efforts to assist business during the pandemic.

Scott Angel with STORE Capital provided a recorded comment regarding that status of their property at 8505 Auburn Blvd.

Graham Allchorn with Red Mountain Group, owner of the Big Lots and Citrus Grove parking lot, provided an overview of their response to the pandemic.

Huber explained that for the Small Business COVID-19 Recovery Grant Program, eligibility is open to businesses located and licensed in Citrus Heights. Staff aims to make funds easily accessible and most effective. The proposed COVID Recovery Grants are based on pre-COVID revenue generation, which would allocate amounts from \$5,000 - \$25,000, depending on gross revenue. All home-based businesses would receive a flat grant amount of \$500. Proposed next steps include a streamlined and expedited application process, launching the initial application period for 30 days, businesses can submit applications online, and staff would then review application and make eligibility determination. The total of the Small Business Recovery Grant program would be approximately \$1.4 million. Huber also proposed a second part to the COVID Recovery Grant Program that targets tourism and entertainment businesses or property owners. Staff recommends City Council allocate \$1,000,000 to the Tourism & Entertainment COVID Recovery Grant program. Staff expects to launch the program in mid-January following Council's guidance.

Council Member Bruins inquired if any other entertainment or tourism businesses other than those presented that could benefit from grant funding. She also stated if the Small Business community does not utilize all of the funding allocated for the grant program, then the rest should be moved to help entertainment and tourism.

Vice Mayor Schaefer stated he would like to make sure the grant funding is actually used to benefit the business community.

Council Member Daniels would like to see more ARPA funds go to help Citrus Heights businesses. He expressed his concern with allocating \$1 million to the former Studio Movie Grill site as opposed to covering multiple businesses.

21. <u>SUBJECT:</u> Regional Sacramento Abandoned Vehicle Service Authority (SAVSA) Possible Ballot Measure Update <u>DEPARTMENT</u>: Police Department

Chief Turcotte addressed Council regarding the Regional Sacramento Abandoned Vehicle Service Authority (SAVSA) Ballot Measure. SAVSA provides funds to the City, which assist with vehicle abatement. The revenue is generated by a \$1 fee added to vehicle registrations by the State of California. The item was initially brought to the Councils attention in June 2021 with the anticipated ballot measure costs to the City being \$62,000. In August 2021, Council was informed the updated ballot measure would cost \$12,000, which falls within the City Mangers approval threshold. Annually, the City received \$50-\$60k from the SAVSA funding. Due to the significantly lower cost, the City Manager intends to enter into an agreement with Sacramento County to support a measure if placed on the ballot.

Summary and Recommendation

Staff recommends the City Council adopt Resolution No. 2022-_____ a resolution making the legally required findings to continue to authorize the conduct of remote "telephonic" meetings during the State of Emergency.

Fiscal Impact

There is no fiscal impact associated with this item.

Background and Analysis

At the October 14, 2021 regular meeting, the City Council adopted Resolution No. 2021-082 authorizing the conduct of remote "telephonic" meetings during a declared state of emergency pursuant to Government Code. The City Council determined that as a result of the COVID-19 pandemic and state of emergency, meetings in person of the City Council and all legislative bodies of the City would present imminent risks to the health or safety of attendees.

In the event of an ongoing proclaimed state of emergency, in order to continue to conduct meetings remotely, any time after the first remote meeting of the legislative body, it can meet remotely if both of the following apply:

- 1. State/local emergency/social distancing. Either:
 - a. "a state of emergency remains active" or
 - b. "state or local officials have imposed or recommended measures to promote social distancing" and

2. <u>30 days</u>. Within the last 30 days (which vote may occur at that meeting) the legislative body has made the following findings by majority vote "(A) The legislative body has reconsidered the circumstances of the state of emergency. (B) Any of the following circumstances exist (i) The state of emergency continues to directly impact the ability of the members to meet safely in person. (ii) State or local officials continue to impose or recommend measures to promote social distancing."

If the City intends to conduct meetings remotely, it should add to every agenda a consent calendar item to reaffirm the findings described above, which are required to allow the remote meetings. This resolution also makes the necessary finings for all subordinate legislative bodies of the City, such as the Planning Commission, so these bodies can also continue to meet remotely on an ongoing basis.

<u>Summary</u>

With the pending retirement of City Manager Chris Boyd, the City Council embarked on a comprehensive search for a new City Manager. After hiring an executive search firm and conducting interviews, the City Council is prepared to select a new City Manager. The top candidate was Mr. Ashley Feeney.

Fiscal Impact

If the Council chooses Mr. Feeney as its next City Manager, the attached Employment Agreement is proposed. The key components of the Agreement are the following:

The Agreement is for a term of 4 years. Mr. Feeney will receive an annual salary of \$240,000. He is entitled to health, dental, medical, and vision insurance consistent with what is provided to others in the Executive Team. Mr. Feeney will receive deferred compensation in the amount of \$7,500 annually, which will be paid into the City's 457 plan, and he will receive a 5% salary match in a 401(a) plan. Mr. Feeney will initially accrue leave at a rate of 160 hours per year.

Pursuant to subsection (3) to Government Code § 54953(c), prior to the City Council taking final action, staff will provide an oral report summarizing the financial highlights of the proposed Agreement.

EMPLOYMENT AGREEMENT

CITY OF CITRUS HEIGHTS

This Agreement is entered into by and between the City of Citrus Heights, California, a municipal corporation ("City") and Ashley Feeney ("Employee"), as of January 13, 2022.

SECTION 1. EMPLOYMENT

City hereby employs Employee as City Manager on the terms and conditions set forth herein. Employee is an at-will employee of the City.

SECTION 2. DUTIES

Employee shall perform the functions and duties specified in the laws of the State of California and by City ordinance, resolution, and official action. Employee shall also perform such other duties and functions as the City, acting through the City Council, shall direct from time to time.

SECTION 3. TERM OF AGREEMENT

Employee shall begin his duties as City Manager, as of January 30, 2022, or a mutually agreeable date sooner, and shall continue with such duties until January 29, 2026.

SECTION 4. TERMINATION OF AGREEMENT

- A. This Agreement may be terminated by Employee or City on any of the conditions set forth below:
 - 1. By Employee, upon ninety (90) days prior written notice to the Mayor.
 - 2. By City, without cause, upon City's payment to Employee of an amount equal to nine (9) months of salary, plus any accrued and unpaid leaves available for cashing out consistent with the City's policy.
 - 3. By City, without payment of any unearned or additional salary past the termination date, but with payment for any accrued and unpaid leaves available for cashing out consistent with the City's policy, for any of the following:
 - a. Repeated acts of immoral or unprofessional conduct.
 - b. Dishonesty.
 - c. Repeated violations of or refusal to obey the state or

municipal laws and regulations or the direction of the City Council.

- d. Conviction of a felony or any crime involving moral turpitude.
- e. Breach of this Agreement.
- 4. Notwithstanding the above, City shall not terminate Employee's employment without cause within 120 days immediately following a general municipal election or appointment at which a new, not currently serving, member of the Council is sworn into office.
- B. Employee shall remain in the exclusive employ of City, except that City acknowledges that Employee may with prior written approval of the City Council engage in other professional activities (including teaching, writing, consulting, and the like) as long as these activities do not interfere or conflict with Employee's duties as City Manager and are otherwise consistent with any limitations set forth in the Fair Political Practices Act and related regulations.

SECTION 5. SALARY

City agrees to pay Employee for services rendered an annual salary of two hundred forty thousand dollars (\$240,000), payable in installments at the same time as other City employees are paid. The City Council, at its sole discretion, may grant merit increases to Employee. The City Council will consider a salary increase and potential contract extension with Employee approximately six (6) months prior to the end of the term of the Agreement.

SECTION 6. BENEFITS

- A. City shall pay for health, dental, and vision insurance for Employee and for Employee's dependents in the same manner as City pays for such benefits for other senior management employees. City may pay for such insurance if required to do so by the City's health insurance plan.
- B. City shall pay for life and disability insurance for Employee in the same manner as City pays for such benefits of other senior management employees.
- C. City shall pay its share of PERS contributions consistent with a PEPRA employee.
- Employee participates along with the City's Executive team in the ICMA-RC 401(a) plan. The plan mandates that all executive members, including Employee, contribute a minimum of 5% of their salary and the City provides

a matching maximum 5% contribution on a dollar-for-dollar basis.

- E. City shall pay annually deferred compensation for Employee in the amount of \$7,500 to the City's 457 plan.
- F. Employee shall be entitled to all other benefits provided to City executive employees.

SECTION 7. LEAVE

Effective January 30, 2022, Employee have 80 hours of annual leave available to him. Thereafter, Employee's shall accrue leave at the rate of 160 hours per year (i.e. 6.16 hours per pay period), with a maximum accrual of 320 hours. Annual leave may be cashed out of up to 80 hours per year.

SECTION 8. PERFORMANCE EVALUATION

The City Council shall endeavor to review and evaluate Employee's performance annually. Nothing in this provision shall be construed to require City to grant Employee merit increases based on the performance evaluation nor to limit the discretion of City to grant merit increases.

SECTION 9. PROFESSIONAL DEVELOPMENT

City shall budget and pay for the professional dues, subscriptions and membership of Employee necessary for his continuation and full participation in national, regional, state and local associations and organizations necessary and desirable for his continued professional participation, growth and advancement and for the good of the City. Employee shall keep the Council reasonably informed of such activities in a manner mutually agreeable to Employee and Council.

SECTION 10. REIMBURSEMENT FOR EXPENSES

Employee shall be entitled to reimbursement of reasonable business-related expenses.

SECTION 11. BONDING

City shall bear the cost of any fidelity or other bond required of Employee under any applicable law or ordinance.

SECTION 12. MISCELLANEOUS

A. City, in consultation with Employee, shall set any other terms and conditions of employment as City may determine from time to time, relating to Employee's performance, provided such terms and conditions are not inconsistent with or in conflict with the provisions of this Agreement, the Municipal Code, or any other law.

B Unless otherwise specifically provided herein, all provisions of the Municipal Code and regulations and rules of City relating to annual leave, long term medical and executive management leave, retirement system contributions, holidays and other fringe bene fits and working conditions as they now exist or hereafter may be amended shall also apply to Employee as they would to any other senior management employee of City.

SECTION 13. NOTICES

Notices pursuant to this Agreement shall be in writing, given by depositing in the U.S. Mail, postage prepaid, addressed as follows:

Alternatively, notices required pursuant to this Agreement may be personally served in the same manner as is applicable to the civil judicial process. Notice shall be deemed given as of the date of personal service or as of the date of deposit of such written notice in the U.S. mail.

SECTION 14. GENERAL PROVISIONS

- A. This Agreement shall constitute the entire agreement between the parties hereto, and expressly supersedes any and all other agreements, either oral or in writing, between the parties hereto with respect to the employment of Employee by City. Each party to this Agreement acknowledges that no representations, inducements, promises or agreements, orally or otherwise, have been made by any party, or anyone acting on behalf of any party, which are not embodied herein, and that no other agreement, statement, or promise not contained in this Agreement shall be valid or binding on either party hereto.
- B. This Agreement shall be binding upon and inure to the benefit of the heirs at law and executors of Employee.

- C. If any provision or any portion hereof, contained in this Agreement is held unconstitutional, invalid or unenforceable, the remainder of this Agreement or portion thereof shall be deemed severable, shall not be affected thereby and shall remain in full force and effect.
- D. Any modification of this Agreement shall be effective only if in writing and signed by both Employee and City, as approved by the City Council.
- E. This Agreement shall be governed by the laws of the State of California. The venue for any and all litigation arising from th.is Agreement shall be in the superior court located in Sacramento County, California.
