



CITY OF CITRUS HEIGHTS NOTICE OF PUBLIC HEARING

NOTICE is hereby given that on **October 10, 2019 at 7:00 p.m.**, or as soon thereafter as the matter may be heard, the **City Council** of the **City of Citrus Heights** will hold a Public Hearing at the **Citrus Heights Council Chambers located at 6360 Fountain Square Drive, Citrus Heights, CA** to consider the following action:

2020-2024 Consolidated Plan and 2020 Action Plan for the Community Development Block Grant Program

The purpose of this public hearing is to hear public comment on the 2020-2024 Consolidated Plan and 2020 Action Plan for the Community Development Block Grant (CDBG) program and to continue final action by Citrus Heights City Council at the October 24, 2019 City Council meeting.

The 2020-2024 Consolidated Plan is a 5-year planning document required by the U.S. Department of Housing and Urban Development (HUD) and outlines the city's needs and priorities for federal CDBG funding. The overall goal of the CDBG program is to develop viable urban communities by providing decent housing, providing suitable living environment, and expanding economic opportunities.

In addition to the five-year Consolidated Plan, the city is required to adopt an Action Plan. The 2020 Action Plan allocates CDBG funds to activities that will be accomplished that calendar year, including public service activities, housing programs, public infrastructure improvements, as well as planning and administration. The city's 2020 Action Plan must align with the goals and priorities outlined in the 2020-2024 Consolidated Plan.

The release of this notice is one of the city's activities to fulfill citizen participation requirements. Federal regulations require jurisdictions to provide the public with reasonable access to the documents.

The 2020-2024 Consolidated Plan and 2020 Action Plan will be available for public review at the following locations on September 26, 2019: Citrus Heights City Hall, 6360 Fountain Square Drive, Sylvan Oaks Library, 6700 Auburn Boulevard, during regular business hours and at www.citrusheights.net. The public review and comment period will begin September 26 and will end October 24, 2019. The City Council will consider the 2020-2024 Consolidated Plan and 2020 Action Plan on October 10. The City Council will consider adoption of the final 2020-2024 Consolidated Plan and 2020 Action Plan on October 24.
